#### Activity:

- Made several new purchases in the quarter, including Alicorp, Allied Irish Banks, Luxottica, and WPP AUNZ.
- Liquidated positions in Aggreko, Fugro, Prada, and Spotless Group.
- Top contributors for the quarter were Keywords Studios (+1.18%), KSB (+0.83%), and Ryanair (0.82%).
- Largest detractors for the quarter were Fugro (-0.08%), Allied Irish Banks (-0.07%), and Spotless Group (-0.04%).

## Positioning:

- Approximately 65% invested (VS. 63% at Q1 2017). Top 10 holdings amount to 30% of total assets. The portfolio's weighted average market capitalization is approximately \$22 billion.
- The Fund's cash stake decreased slightly to 35%.
- European equities continue to account for the majority of the Fund's geographic exposure, at almost half of total assets, with continued exposure to the Pacific Basin (10%), and little change to emerging markets equities (12%).

## Outlook:

 Management remains concerned by the general unbridled inflation in market prices, rendering opportunities limited and growing difficult to keep pace with equity markets while remaining true to the Fund's investment discipline.
